Sir,

Oil and Natural Gas Corporation Ltd (ONGC) is a promoter company of ONGC Petro additions Ltd (OPaL).

In terms of Regulation 7(2) of SEBI, (Prohibition of Insider Trading) Regulations, 2015, it is hereby declared that ONGC has acquired and paid the investors/ bankers a sum of Rs 492 Cr towards CCD-III and Rs 5,615 Cr towards CCD-I. The said CCDs have been duly credited to the DMAT account of ONGC. ONGC on 06.09.2024 requested OPaL to convert CCDs of Rs 6107 Cr into equity shares of OPaL.

Accordingly, Security allotment committee of OPaL met on 12.09.2024 and allotted 6107 million shares of OPaL of face value of Rs 10/- each.

Due to the above allotment of equity shares, the stake of ONGC in OPaL has increased from 81.2914% (444,92,20,632 shares) to 91.1577% (1055,62,20,632 shares)
