Reference is invited to the disclosure by the Company vide letter No. OPaL/CS/BSE/2025/Reg 51(2) dated March 07, 2025 (copy enclosed).

Pursuant to Regulation 51(2) and other applicable regulations, if any, read with Part B of Schedule-III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('LODR'), it is to further inform that ONGC Petro additions Limited ("the Company") has received a letter dated May 01, 2025 from the Government of India, Ministry of Commerce and Industry, Office of the Development Commissioner, Dahej Special Economic Zone ("Dahej SEZ"), Ahmedabad that *the "Central Government has in exercise of power conferred by second proviso to sub-section (1) of Section 4 of the SEZ Act, 2005 and in pursuance of Rule 8 of the SEZ Rules 2006, de-notified an area of 529.4586 Hectares of Dahej SEZ Ltd. vide Notification dated 01.05.2025."*

Accordingly, the unit M/s ONGC Petro additions Limited shall not use the entry and exit gates of Dahej SEZ with effect from 02.05.2025. Further, the Developer i.e. M/s Dahej SEZ Limited is requested to take necessary steps to ensure that the SEZ boundaries are maintained in line with the applicable provisions of the SEZ Act/Rules and other instructions issued in this regard from time to time. Also, the specified officer of Dahej SEZ Ltd. has been requested to ensure that M/s ONGC Petro additions Limited shall not use the SEZ premises/facilities henceforth.
