CE rating: The CE rating is driven by the unconditional and irrevocable mandatory put option on OPaL's sponsor, Oil and Natural Gas Corporation Limited (ONGC; 'IND AAA'/Stable), for the buyback of the CCDs at the end of the specified tenure from the deemed date of allotment. The CCDs carry annual coupon payments. The sponsor shall be unconditionally and irrevocably liable to fund the service account for coupon payments, on or before the relevant coupon payment date, in case OPaL is unable to do so.

The unsupported rating is the same as the Long-Term Issuer Rating of 'IND AA'/Stable.

**Analytical Approach**: Ind-Ra continues to factor in the strong legal, strategic and operational linkages of OPaL with ONGC (holding 49.4% shareholding) to arrive at the ratings.

Note: There has been an amendment to the terms of the CCDs amounting to INR16.71 billion. These CCDs were due for a mandatory put option on the sponsor on 15 October 2021, that being the 53rd month from the deemed date of allotment i.e. 18 May 2017. However, the management, with the acceptance from its investors, has entered into amendment agreements for increasing the tenure of the said CCDs to 72 months from 54 months prior to the exercise of the mandatory put option. As a result, the mandatory put option is now applicable at the end of 71st month from the deemed date of allotment, and the interim buyout option remains with the sponsor at the end of specified periods. Furthermore, according to the amended terms, the annual interest rate has been revised to 5.58% from 8.6%, which would be payable semi-annually, with the next coupon payable on 18 April 2022. The other majority terms of the CCDs remain unchanged, along with the unconditional irrevocable liability of the sponsor to fund the service account for coupon payments on or before the relevant coupon date in case the issuer is unable to do so. Ind-Ra has reviewed the amended documents, in line with the agency's requirement for affirming the ratings.

#### KEY RATING DRIVERS

Continued Strong Linkages with Sponsor: The ratings continue to factor in the strong linkages between OPaL and ONGC, given ONGC has provided strong financial support by infusing INR43.63 billion at FYE21 (FYE20: INR34.92 billion) by way of equity and convertible share warrants. ONGC has also provided support by way of providing mandatorily put option to investors for INR77.78 billion of CCDs raised by OPaL. These CCDs also have an unconditional irrevocable liability from ONGC to fund the service account for coupon payments on or before the relevant coupon date in case the OPaL is unable to do so.

Ind-Ra believes ONGC may continue infusing additional funds in OPaL through equity-like instruments to support the latter's debt-servicing requirement; although given the improved profitability of OPaL, ONGC has also provided a letter of comfort with an overall
